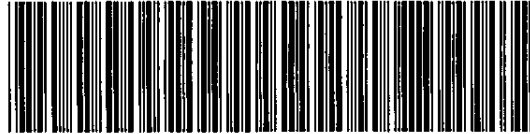

**ARTICLES OF INCORPORATION  
OF  
INNOVATIVE DESIGNS, RESEARCH & EDUCATION FOR  
NEXT-GEN SYSTEMS, INC.**

The undersigned person, being over the age of twenty one (21) years old and sui juris, in the capacity of incorporator(s) of the following corporation, under the Florida Business Corporation Act, hereby file these Articles of Incorporation, pursuant to Section 607, Florida Statutes.

**ARTICLE I  
NAME AND MAILING ADDRESS**

The name and mailing address of the Corporation shall be **INNOVATIVE DESIGNS, RESEARCH & EDUCATION FOR NEXT-GEN SYSTEMS, INC., 3702 S.W. 82<sup>nd</sup> Street, Gainesville, Florida 32608**, as approved by the Board of Directors.

**ARTICLE II  
NATURE OF BUSINESS**

The general nature of the business to be transacted by the Corporation and its objects and power shall be as follows:

**"To provide engineering expertise in resolving technical problems through research and development consisting of (i) analysis and experimentation and (ii) consultation for product development and testing and to engage in any and all activities or business for which the Corporation may be incorporated under the Florida Business Corporation Act and/or permitted under the Laws of the United States and of the State of Florida."**



**ARTICLES III**  
**CAPITAL STOCK**

1. The maximum number of shares of authorized capital stock of this Corporation shall be One Hundred Thousand (100,000) shares of common stock with par value of zero dollar (\$0.00).

2. All common shares shall be identical with each other in every respect and the Holder thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

3. The capital stock may be paid for in property, labor, services or cash at a just valuation to be fixed by the Board of Directors. All of the stock shall be fully paid and non-assessable.

**ARTICLE IV**

The Corporation may have such other places of business in the State of Florida as the nature and progress of the business of the Corporation shall, from time to time, render necessary and/or desirable. The restriction on the transfer, or registration of transfer, of shares shall be authorized to maintain the corporation's status that is dependent on the identity of its shareholders. The restriction imposed on the transfer, or registration of transfer, of shares shall (a) obligate the shareholder(s) first to offer the corporation (separately, consecutively or simultaneously) an opportunity to acquire the restricted shares; (b) obligate the corporation (separately, consecutively or simultaneously) to acquire the restricted shares; (c) require the corporation, or the principal holders of any class of its shares, to approve the transfer of the restricted shares; and (d) prohibit the transfer of the restricted shares to designated persons or classes of persons.

For purposes of these Articles of Incorporation, "shares" shall include a security convertible into, or carrying a right to subscribe for, or acquire shares.
