ARTICLES OF INCORPORATION

OF

WILLIAM C. KEYES, D.M.D., P.A.

The undersigned person hereby adopts Articles of Incorporation in order to form a professional service corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is William C. Keyes, D.M.D., P.A.

ARTICLE II

This Corporation shall commence upon execution of these Articles and shall exist perpetually.

ARTICLE III

The purpose of this Corporation is to provide dental services to the public and this Corporation shall engage in no other business.

ARTICLE IV

This Corporation is authorized to issue Ten Thousand (10,000) shares of \$1.00 par value, common stock.

The shares of this Corporation are not to be divided into classes.

This Corporation is not authorized to issue shares in series.

ARTICLE V

No person shall own or have any interest in any shares of this Corporation unless he or she is duly licensed to provide dental services in the State of Florida.

ARTICLE VI

Every Shareholder, upon the sale for cash of any new stock of this Corporation, shall have the right to purchase his or her pro rata share thereof (as nearly as can be done without issuing fractional shares), at the price at which it is offered to others.

ARTICLE VII

The initial street and mailing address of the principal place of business of the Corporation is 190 S. Sykes Creek Parkway, Suite 2, Merritt island, Florida 32952. The initial address in Florida of the initial registered office of this Corporation is 2200 Front Street, Suite 301, Melbourne, Florida 32901, and the name of the initial registered agent of this Corporation at that address is J. The initial Board of Directors shall consist of one (1) Director initially. The number of Directors may be either increased or diminished from time to time by the Bylaws, but shall never be less than one.
