ARTICLES OF INCORPORATION OF STEPHEN F. BEISSINGER, M.D., FACS, P.A.

ARTICLE I NAME, PRINCIPAL PLACE OF BUSINESS, AND DURATION

The name of the Corporation is Stephen F. Beissinger, M.D., FACS, P.A. The street address of the initial principal office of the Corporation is 270 Overlook Drive, Winter Haven, Florida 33884. The duration of the Corporation is perpetual.

ARTICLE II REGISTERED OFFICE AND AGENT

The street address of the initial registered office in the State of Florida is 270 Overlook Drive Winter Haven, Florida 33884. The name of the initial registered agent at such address is Stephen F. Beissinger.

ARTICLE III CORPORATE PURPOSES, POWERS, AND RIGHTS

- 1. The nature of the business to be conducted or promoted is to engage in the practice of medicine. The purpose of the Corporation is any lawful act or activity for which a professional service corporation engaged in such profession may be organized under the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, and for which such a corporation is permitted to engage in under other applicable law.

The merger or consolidation of the Corporation into or with any other corporation, the merger of any other corporation into it, or any purchase or redemption of shares of stock of the Corporation for the purposes of this paragraph.
- (c) Each holder of Common Stock has one vote with respect to each share of stock held by him or her of record on the books of the Corporation on all matters voted upon by the shareholders.
- (d) The private property of the shareholders of this Corporation shall not be subject to the payment of corporate debts, except to the extent of any unpaid balance of subscription of shares.
- (e) Any person, upon becoming the owner or holder of any shares of the Common Stock or other securities having voting rights issued by this Corporation ("shareholder"), does thereby consent and agree that all rights, powers, privileges, obligations, or restrictions pertaining to such person or such securities in any way may be altered, amended, restricted, enlarged, or repealed by legislative enactments of the State of Florida or of the United States hereafter adopted which have reference to or affect corporations, such securities, or such persons if any; and that the Corporation reserves the right to transact any business of the Corporation, to alter, amend, or repeal these Articles of Incorporation, or to do any other acts or things as authorized, permitted, or allowed by such legislative enactments.
