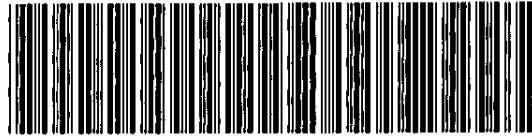

**ARTICLES OF INCORPORATION  
OF  
T. RIPPEL CONSTRUCTION, INC.**

Pursuant to the Florida Business Corporation Act, the undersigned authorized representative submits these Articles of Incorporation for the purpose of forming T. Rippe Construction, Inc. (the "Corporation").

**ARTICLE I  
CORPORATE NAME**

These Articles of Incorporation shall be effective upon filing.




