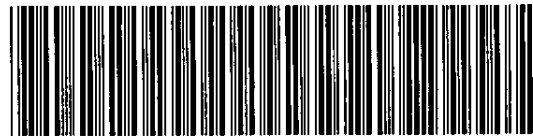



The undersigned incorporator of this professional service corporation, executing these Articles of Incorporation, being a natural person duly licensed to practice law under the laws of the state of Florida, and competent to contract, hereby forms this professional service corporation under the laws of the State of Florida.

ARTICLE I
NAME

The name of this professional service corporation is L.O.O.J.B., P.A.

ARTICLE II
PRINCIPAL OFFICE

The principal street address and mailing address is 18831 SR 20 W., Suite B, Blountstown, FL 32424.

ARTICLE III
NATURE OF BUSINESS

The general nature of the business to be transacted by this professional service corporation is legal services, that might include to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, tangible and intangible, and services of every class, kind and description; and to conduct any other business and carry on any other activity as may be permissible under law; except that it is not to conduct a banking, safe deposit trust, surety, express, railroad, canal, telephone, telegraph, or cemetery company, a building and loan association, fraternal benefit society, state fair, nor exposition.

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at one time is 100 shares of common stock having a nominal or par value of \$1.00 per share.

None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice law in the state of Florida.

ARTICLE V
INITIAL CAPITAL

The amount of capital with which this corporation will begin business is not less than \$100.00.

ARTICLE VI
TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VII
ADDRESS AND RESIDENT AGENT

This corporation shall have 1 director, initially. The number of directors may be increased or diminished from time to time, by bylaws adopted by the stockholders, but shall never be less than one (1).

ARTICLE IX

ARTICLE X
AMENDMENT

ARTICLE XII
PREEMPTIVE RIGHTS


