In compliance with Florida Business Corporation Act, the undersigned, acting as incorporator of a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME OF CORPORATION

The name of the Corporation is ITALA Corporation (the "Corporation").

ARTICLE II

PRINCIPAL OFFICE

The initial principal office and mailing address of the Corporation is 2600 SW 3rd Avenue, Suite 350, Miami, Florida 33129.

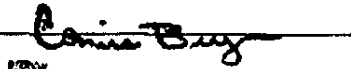
