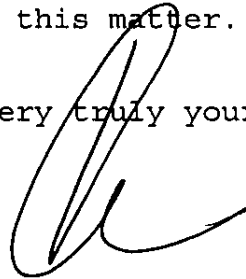

I the undersigned incorporator of this Corporation under Chapter 607, Florida Statutes, as amended, adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation is Charles E. Butler III, PROFESSIONAL ASSOCIATION. The principal office of this corporation is: 6574 N. State Road 7, #384, Coconut Creek, FL 33073.

ARTICLE II

This duration of this corporation shall be perpetual, commencing on the 3rd day of March, 2016.

ARTICLE III

The specific nature of business of the Professional Association is the practice of law and related services. Said corporation shall have all the corporate powers and authority permitted or allowed by the laws of the State of Florida to carry out the lawful business of the corporation.

ARTICLE IV

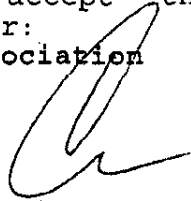
