**ARTICLES OF INCORPORATION
OF
MASH SERVICES INC.**

The undersigned, acting as incorporator of MASH SERVICES INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Mash Services Inc. (the "Corporation").

ARTICLE II. ADDRESS

The principal and mailing address of the Corporation is 515 East Las Olas Boulevard, Suite 1200, Ft. Lauderdale, Florida 33301.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE X. AMENDMENTS




