The name of the corporation shall be: **Jax HVAC, Inc.** (the "Corporation").

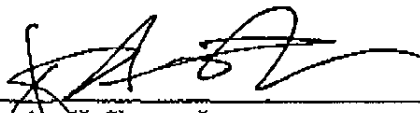
ARTICLE VI - INCORPORATOR
