The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I <u>Name</u>

The name of this corporation shall be PETER L. KOVACS, M.D., P.A.

Article II Principal Office and Mailing Address

Article III Capital Stock

- 3.1. <u>Capital Stock</u>. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock. No other person other than a professional corporation, a professional limited liability company, or an individual, each of which must be duly licensed or otherwise legally authorized to practice as a physician in the State of Florida, shall be a shareholder of this professional corporation.
- 3.2. Restriction on Transfer of Stock. Article VI <u>Effective Date; Duration</u>

- 6.1. <u>Effective Date</u>. Corporate existence shall commence on the date these Articles are executed.
 - 6.2. <u>Duration</u>. This corporation shall exist perpetually.

Article VII Purposes

- 8.1. <u>Number of Directors</u>. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time, but shall never be less than one.
