**ARTICLES OF INCORPORATION
OF
MYMATRIXX HOLDINGS, INC.**

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE 1

Name

The name of this corporation shall be:

myMatrixx Holdings, Inc.

ARTICLE 2

Principal Office and Mailing Address

The address of the principal office and the mailing address of this corporation shall be:

ARTICLE 3

Business and Purposes

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

ARTICLE 4

Capital Stock

(a) The aggregate number of shares of capital stock authorized to be issued by this corporation shall be seventy million (70,000,000) shares of stock, par value \$0.001 per share, in two separate classes, as follows: (i) thirty-five million (35,000,000) shares of common voting stock and (ii) thirty-five million (35,000,000) shares of common non-voting stock. Each share of common voting stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation; and the voting power of this corporation shall be entirely vested in its common voting stock. Except as otherwise required by law, shares of common non-voting stock shall have no voting rights. Aside from differing voting rights, shares of common voting stock and common non-voting stock shall be equivalent in all respects, including with respect to rights to dividends and liquidation proceeds. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, in cash, in promissory notes, in other property (tangible or intangible), in labor or services actually performed for this corporation, in promises to perform services in the future evidenced by a written contract, or in other benefits to this corporation at a fair valuation to be fixed by the Board of Directors. When issued, all shares of stock shall be fully paid and nonassessable.

(b) In the election of directors of this corporation, there shall be no cumulative voting of the stock entitled to vote at such election.

ARTICLE 5

Existence of Corporation

This corporation shall have perpetual existence.

ARTICLE 6

Registered Office and Registered Agent

The registered office of this corporation shall be located at 3111 W. Dr. Martin Luther King Jr. Boulevard, Suite 800, Tampa, Florida 33607, and the registered agent of this corporation at such office shall be Thomas W. Cardy. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE 7**Board of Directors**

The Board of Directors of this corporation shall consist of not less than one (1), nor more than fifteen (15) members, the exact number of directors to be fixed from time to time by the stockholders holding common voting stock or the bylaws. The business and affairs of this corporation shall be managed by the Board of Directors, which may exercise all such powers of this corporation and do all such lawful acts and things as are not by law directed or required to be exercised or done only by the stockholders. A quorum for the transaction of business at meetings of the directors shall be a majority of the number of directors determined from time to time to comprise the Board of Directors, and the act of a majority of the directors present at a meeting at which a quorum is present shall be the act of the directors. Subject to the bylaws of this corporation, meetings of the directors may be held within or without the State of Florida. Directors need not be stockholders. The stockholders of this corporation holding common voting stock may remove any director from office at any time with or without cause.

ARTICLE 8**Initial Board of Directors**

The initial Board of Directors of this corporation shall consist of five (5) members, such members to hold office until their successors have been duly elected and qualified. The names and street addresses of the initial directors are:

ARTICLE 10

Bylaws

(a) The power to adopt the bylaws of this corporation, to alter, amend or repeal the bylaws, or to adopt new bylaws, shall be vested in the Board of Directors of this corporation; provided, however, that any by-law or amendment thereto as adopted by the Board of Directors may be altered, amended or repealed by vote of the stockholders entitled to vote thereon, or a new by-law in lieu thereof may be adopted by the stockholders holding common voting stock, and the stockholders holding common voting stock may prescribe in any by-law made by them that such by-law shall not be altered, amended or repealed by the Board of Directors.

(b) The bylaws of this corporation shall be for the government of this corporation and may contain any provisions or requirements for the management or conduct of the affairs and business of this corporation, provided the same are not inconsistent with the provisions of these Articles of Incorporation, or contrary to the laws of the State of Florida or of the United States.

ARTICLE 11

Amendment of Articles of Incorporation




