It has come to my attention that on or about June 12, 2024, Sunship Inc. filed its 2024 Amended Annual Report ("2024 Amended Report") by way of a listed Officer, specifically President, Jessica Cappock, also therein listed as registered agent. A true and accurate copy of the 2024 Amended Report is enclosed herein for ease of reference. The corresponding registered agent address is 515 E. Las Olas Blvd, Suite 120, Fort Lauderdale, FL 33301, which at that time was the virtual office location of Mathis Law Group of which Jessica Cappock, the undersigned, is a partner attorney. Upon information and belief, the Jessica Cappock, listed by Sunship in the 2024 Amended Report references the undersigned, Jessica Cappock, with a scrivener's error. This letter serves as notice to the Secretary of State that such submission was inaccurate and fraudulent.

Specifically, the undersigned **did not execute the 2024 Amended Report, nor have any knowledge of the same whatsoever** at the time of filing. At no time has the undersigned been affiliated whatsoever with Sunship, Inc. and its operations. Upon information and belief, the appropriate officer, Luis Lopez at 6650 Pinetree Lane, Miami Beach, FL 33141, fraudulently submitted the 2024 Amended Report. Pursuant to the foregoing, the undersigned requests that the appropriate steps be taken to remove Jessica Cappock from the listed officers and as registered agent for Sunship, Inc. and further record a statement addressing the issues raised herein to ensure no future association remains whatsoever between Jessica Cappock and Sunship, Inc. and any other further action as you deem appropriate pursuant to Sunship, Inc.'s recording of a forged and fraudulent 2024 Amended Report.

as Officer/President of Sunship, Inc. once completed. It is important to note that a Resignation of Registered Agent has been simultaneously executed and included herein for reference.




