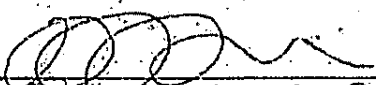

The undersigned, acting as incorporator of PRICE ERASER INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation is PRICE ERASER INC. (the "Corporation").

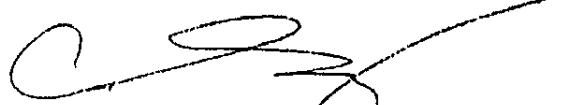
#### ARTICLE IX. BYLAWS
