## ARTICLES OF INCORPORATION OF PURE-GRO, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business. Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

PURE-GRO, INC.

Article 2. Mailing Address. The mailing address of the Corporation is:

Article 3. Duration. The duration of the Corporation is perpetual.

Article 4. Purpose. The general purposes for which the Corporation is organized are the following:

In the event these Articles of Incorporation are not filed within the time period set forth in Section 607.0203, Florida Statutes, the date when corporate existence shall commence is the date of filing by the Secretary of State.
