Article V is hereby deleted and in lieu thereof the following Article shall be added:

ARTICLE V

The total number of shares which the Corporation shall have authority to issue is ten thousand (10,000) common shares, consisting of one hundred (100) shares of a single class of shares to be known as Class A common shares, and nine thousand nine hundred (9,900) shares of a single class of shares to be known as Class B common shares. The Corporation shall have the authority to issue fractional shares of both Class A common shares and Class B common shares.

A shareholder who owns one or more Class A common shares shall be entitled to vote with respect to Corporation matters.

A shareholder who owns one or more Class B common shares (and no Class A common shares) shall not be entitled to vote.

Class A common shares and Class B common shares shall otherwise have identical rights and characteristics.


