Pursuant to the provisions of Section 607.1006, Florida Statutes, TGH Ancillary Holding Company (the "Corporation") adopts the following amendments to its Articles of Incorporation:

- 1. <u>Name of Corporation.</u> The name of the Corporation is TGH ANCILLARY HOLDING COMPANY.
 - 2. <u>Text of Amendments.</u>
 - A. Article I is deleted in its entirety and substituted with the following:

ARTICLE I

<u>NAME</u>

The name of the Corporation is TGH Ambulatory Services Company.
