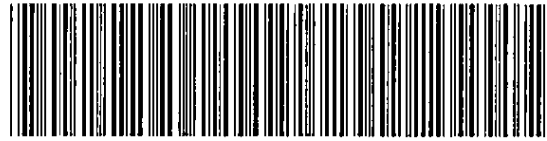

Pursuant to the provisions of Section 607.1006, Florida Statutes, TGH Ancillary Holding Company (the "Corporation") adopts the following amendments to its Articles of Incorporation:

1. Name of Corporation. The name of the Corporation is TGH ANCILLARY HOLDING COMPANY.

2. Text of Amendments.

A. Article I is deleted in its entirety and substituted with the following:

ARTICLE I

NAME

The name of the Corporation is TGH Ambulatory Services Company.

3. Date of Adoption. The amendment was adopted on August 1st, 2019.

4. Manner of Approval. The sole shareholder voted all outstanding shares in favor of the amendment, which is sufficient for approval.
