

**ARTICLE OF INCORPORATION  
OF

The undersigned subscribers to this Article of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be:

INDIGENOUS EMPIRE, INC.

**ARTICLE II. NATURE OF BUSINESS**

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida namely but not limited to do Credit history clearing, Repairing of credit profile, Counseling service, Creative Health and Beauty, Creative Arts, Sales and Marketing, Realtor and any other activity permitted under the laws of Florida.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time shall be as follows: Three Thousand (3,000) shares of common stock having a par value of \$1.00 per share.
