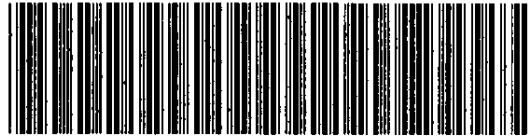

**ARTICLE I - Name**

The name of this corporation is AMERICAN TRUCK BROKERS, INC.
