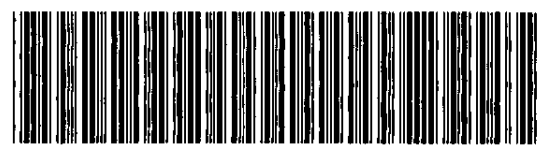



5. INCORPORATOR. The name and street address of the incorporator is Tracy M. Fox, 5557 Lorraine Road, Bradenton, Florida 34211.


