**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
SDII GLOBAL HOLDING CORPORATION**

SDII GLOBAL HOLDING CORPORATION, a Florida corporation (the "Corporation"), whose Articles of Incorporation were originally filed with the Florida Department of State on April 15, 2016; (Florida Division of Corporations Document Number P16000034111), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

**"ARTICLE I
CORPORATE NAME AND PRINCIPAL OFFICE**

*The name of this Corporation is **C&C GLOBAL HOLDING II CORPORATION** (the "Corporation") and its principal office and mailing address is **4509 George Road, Tampa, Florida 33634***

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.

3. The amendment recited in Section 1. above has been duly adopted in accordance with the provisions of §607.0704, .0821, .1003, and .1006, Florida Statutes; the directors and the shareholders holding sufficient number of votes for approval of the Corporation having executed a written statement, dated as of October 11, 2022, manifesting their intention that the amendment be adopted.
