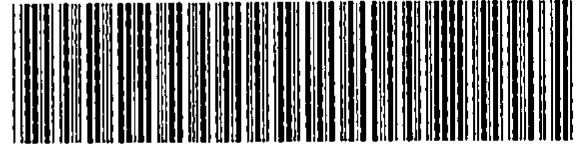

E. Adding additional articles:

ARTICLE VIII

Shareholders have preemptive rights to subscribe to or purchase all shares of stock of Corporation, whether issued initially or at any time after the effective date of the Article Incorporation, and the consideration for such shares is to be determined by the Board Directors.

ARTICLE IX

The Corporation and its common stockholders, or the stockholders of the Corporation among themselves, may enter into any agreement restricting the transferability, assignment, encumbrance or pledge of the stock of this Corporation, whether voluntarily or involuntarily. Any such agreement may confer upon the Corporation, or the stockholders, or both, the option of first refusal or mandatory purchase in the event any stockholder desires to transfer, assign, encumber or pledge stock with or without consideration. Any such agreement may include such restrictions during the lifetime of any stockholder, or upon the death or legal incompetence of any stockholder. Nothing contained in the Articles of Incorporation, Articles of Amendment of Articles of Incorporation, or the By-Laws of the Corporation shall be construed as authorizing a transfer of such stock upon the books of the Corporation in violation of any agreement.

ARTICLE X

These Articles of Incorporation may be amended in the manner provided by law.

ARTICLE XI

Pursuant to the provisions of Chapter 607 of the Florida Statutes, the date of adoption of each amendment shall be the date that this document was executed below. The amendments were adopted by the board of directors without shareholder action, and shareholder action was not required.
