The client/trainers are solely responsible for their entire staffing, contracting, purchasing, scheduling and training operations.
The client trainers will be responsible for their tax liabilities, any workers' compensation and type of liability insurance.
This Corporation will file any Federal Tax Return since the race horse owners are paying and depositing their funds
to this Corporation and this service agent will expect an IRS Form 1099 from the trainers' actual owners- their clients.
The client/trainer's can give this Corporation 30 days written advanced notice in order to cancel this service agreement.
This service agreement can be written or verbal and this Corporation is separate and distinct from its client/trainers and their
training operations. This Corporation may provide services to other client/trainers for similar type full or partial services.
Each client/trainer will be provided monthly and annual financial statements and completed tax returns of its operations.
Each client will have a separate bank account to reflect the client's billings, payments, operating expenses, profit & loss.
