



#### ARTICLES OF INCORPORATION FOR Prado Family Trust, INC

The undersigned, acting as incorporator of this corporation under the Florida general Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I Name of Corporation

The name of this corporation shall be "Prado Family Trust, INC." the corporation should be referred to in this instrument as the "Corporation". These articles of Incorporation shall refer to as "Articles" and the Bylaws of the Corporation shall refer to as "Bylaws".

#### ARTICLE II Initial Registered Office and Agent

### ATICLE III Term of Existence

The period of duration of the Corporation is perpetual.

### ARTICLE IV Purpose

The purpose or purposed for which the Corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this State.

#### ARTICLE V Shares

Number. The aggregate number of shares that the corporation shall have the authority to issue is ten thousand (10,000) shares of Capital Stock with a par value of \$1.00 per share. The number of Directors may be increased or diminished from time to time as determined by the By-Laws, but shall never be less than one. Each of said Directors shall be of full age. Any director may be removed at any annual or special meeting of stockholders called in accordance with the By-Laws of the Corporation, by the same vote as the required to elect a Director.

# ARTICLE XI Amendment of Articles of Incorporation

The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a property noticed stockholders' meeting, with not less than a majority vote of the common stock.

# ARTICLE XII Preemptive Rights

The holders of the common stock of this Corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Director(s), such shares of the stock of this corporation as may be issued for money, or any property or services from time to time in addition to that stock presently authorized and issue by the Corporation. The preventive right of any shareholder is determined by a ratio of the authorized and issued shares of common stock held by the holder of all shares of common stock correctly authorized and issued.
