## ARTICLES OF INCORPORATION OF spotBAC, Inc.

The undersigned, acting as incorporator of a corporation under the Florida Statutes, adopts the following Articles of Incorporation:

FIRST: The name of the corporation is spotBAC, Inc.

SECOND: The period of duration is perpetual.

THIRD: The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Statutes.

FOURTH: The Principal office of the corporation is 9340 Flagler St. Apt. 209, Miami, FL 33174.

FIFTH: The mailing address of the Corporation is 9340 Flagler St. Apt. 209, Miami, FL 33174.

SIXTH: Registered Agent. The address of the initial registered office of the corporation is 9340 Flagler St. Apt. 209, Miami, FL 33174. The registered agent at this address is Mr. Yogeswaran Umasankar.

SEVENTH: The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000). Each share has a par value of one cent (\$0.01).

In case a shareholder desires to sell his or her shares of stock, he or she must first offer them for sale to the remaining shareholders, it being the intention to give them a preference in the purchase of such shares, and any attempted sale in violation of this provision is null and void. A shareholder desiring to sell his or her stock shall file notice in writing of his or her intention with the secretary of the corporation, stating the terms of sale, and unless his or her terms are accepted by any or all of the other stockholders within 14 days thereafter, they shall be deemed to have waived their privilege of purchasing and he or she will be at liberty to sell to anyone else.

EIGHTH: These Articles of Incorporation may be amended by the board of directors adopting a resolution setting forth the proposed amendment. The proposed amendment must then be ratified by a majority vote at a meeting of the shareholders that was properly called and held in Florida in accordance with the provisions of the bylaws.

NINTH: Any director or the entire board of directors may be removed by the shareholders, with or without cause, at a special shareholder meeting called expressly for that purpose in accordance with the requirements for such a meeting as is specified in the bylaws. The method of electing directors shall be stated in the bylaws.
