BY-LAWS





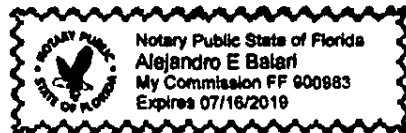
