**ARTICLES OF INCORPORATION  
OF  
AP FRIZZ, INC.**

The undersigned incorporator, Arthur W. Frizzell, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

**ARTICLE I - NAME**

The name of the corporation is AP Frizz, Inc. This corporation is referred to in these Articles of Incorporation as the "Corporation."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The street address and mailing address of the initial principal office of the Corporation is 3050 West Hwy 98, Unit 8, Port St. Joe, Florida 32456.

**ARTICLE III - PURPOSE AND POWERS**

The Corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States. The Corporation shall have all powers that may now or hereafter be lawful for a corporation to exercise under the Florida Business Corporation Act.

**ARTICLE IV - CAPITAL STOCK**

The Corporation is authorized to issue one thousand (1000) shares of one dollar (\$1.00) par value common stock.

**ARTICLE V - COMMENCEMENT OF CORPORATE EXISTENCE  
AND TERM OF EXISTENCE**

The date for commencement of the Corporation's existence shall be the date these Articles of Incorporation are filed with the Florida Department of State. The Corporation shall have perpetual existence.

**ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT**

The address of the initial registered office of the Corporation is 3050 West Hwy 98, Unit 8, Port St. Joe, Florida 32456, and the name of the initial registered agent of the Corporation at that address is Arthur W. Frizzell.

**ARTICLE VII - INITIAL BOARD OF DIRECTORS**

The Corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time pursuant to the bylaws of the Corporation, but

shall never be less than one (1). The name and address of the initial director of the Corporation is:

#### **ARTICLE VIII - INITIAL OFFICERS**

The officers shall be elected by the Board of Directors at the annual meeting of the Board of Directors or as otherwise provided in the Corporation's bylaws.

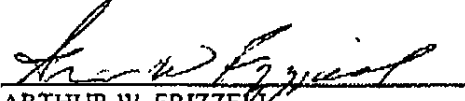

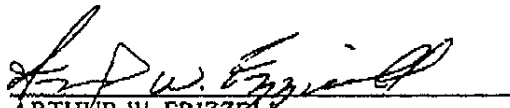
