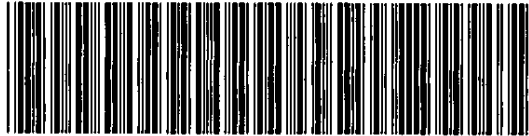

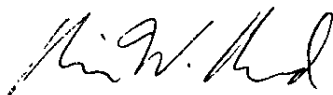

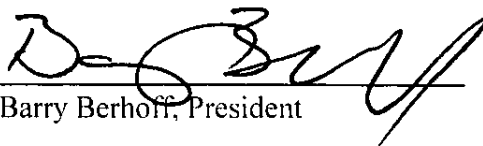

ARTICLE I - NAME

The name of this corporation is: Shurhold Export, Inc.

ARTICLE II - PRINCIPAL OFFICE
