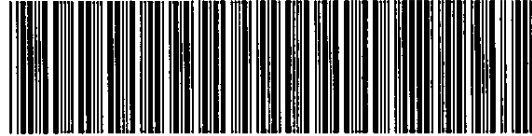

**AMENDED AND RESTATED
ARTICLES OF INCORPORATION OF

Pursuant to Florida Statutes 607.1007, these Amended and Restated Articles of Incorporation of KAMPEN INVEST, INC. were adopted as of August 9, 2016, by written unanimous consent of all the Directors and Shareholders entitled to vote, in accordance with Florida Statutes Sections 607.0704 and 607.0821. The amendments herein do not provide an exchange, reclassification, or cancellation of stock.

ARTICLE I

The name of this Corporation shall be KAMPEN INVEST, INC.

ARTICLE II
