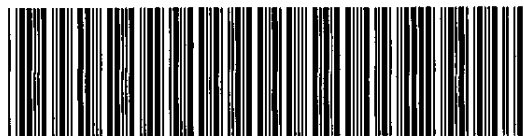

## **ARTICLE XIII TAXATION**




**ARTICLE XIV


