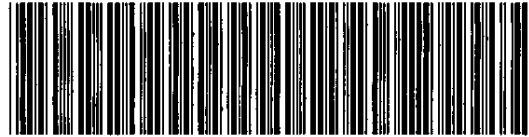



ARTICLE XIV

Preemptive rights: Every shareholder, upon the sale for cash or otherwise, of any new un-issued stock of the corporation of the same kind, class or series as that which he already owns and holds, shall have the right to purchase his pro rata share thereof at the same price and terms at which it is offered to others.


