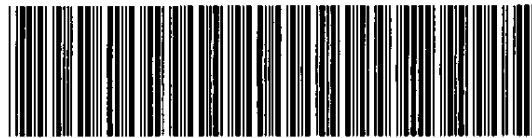

ARTICLE V. DIRECTORS




