# Articles of Incorporation of Cespedes Bed Sheets Corporation

#### ARTICLE I

The name of the corporation is Cespedes Bed Sheets Corporation.

#### ARTICLE II

The general purpose for which the corporation is organized includes the transaction of any and all activities and businesses permitted under the laws of the United States and of the State of Florida. The street address of the principal place of business of the corporation is 445 West 11<sup>th</sup> Street, Hialeah, Florida 33010. The Board of Directors may, from time to time, move the principal office to any other address.

#### ARTICLE VI

The corporation shall have one director initially. The number of directors may be increased or diminished from time to time pursuant to the Bylaws of the corporation, but shall not be less than one nor more than five.

Members of the Board of Directors or of any Executive Committee thereof shall be deemed present at a meeting of such Board or Committee if a conference telephone or similar communications equipment, by means of which all persons participating in the meeting can hear each other at the same time, is used.

A director shall not be prohibited or disqualified from voting on any issue, at any time, by reason of the fact that the issue under consideration may involve such director personally, directly or indirectly, or that it may involve any person, firm, corporation or other entity in which such director has such a direct of indirect interest.

#### ARTICLE XII

Fifty-one (51%) percent of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of shareholders.

If a quorum is present, the affirmative vote of fifty-one (51%) percent of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

#### ARTICLE XIII

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, and any right conferred upon the shareholders is subject to this reservation.

#### ARTICLE XIV

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors, subject to the approval of the shareholders.

#### ARTICLE XV

The approval of the shareholders of this corporation to any plan or merger shall be required in every case whether or not such approval is required by law.

### ARTICLE XVI

The shareholders of this corporation shall have the exclusive authority to fix the compensation of the directors of this corporation.
