# Attachment to Certificate of Incorporation of Black Stallion Drive, Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 11,000 of which 10,000 shares of par value \$0.001 per share shall be designated as Common Stock and 1,000 shares of par value \$0.001 shall be designated as Preferred Stock.
