ARTICLE 1- NAME

The name of the corporation shall be:

ARTICLE II – NATURE OF BUSINESS

This corporation may engage in the transaction of any and all activities permitted under the Laws of Florida and the United States of America.

The maximum number of shares of stock that this corporation is authorized to issue at any time is 1000 common non par value shares.

as to which it shall be adjudged that such officer or director is liable for negligence of will full misconduct in the performance of his duties.

The rights accruing to any persons under the foregoing provision shall not exclude any right to which he may be lawfully entitled nor shall any herein contained restrict the right of the corporation indemnified reimburse such persons in any proper case even though not specifically herein provided.



These Articles of Incorporation may be amended in any or as many respects as may be desired, provided that the amended articles contain only such provisions as might be lawfully contained in the original


articles at the time of the amendment. A charter amendment requires a unanimous vote by the Board of Directors. Restated articles of incorporation may be adopted.

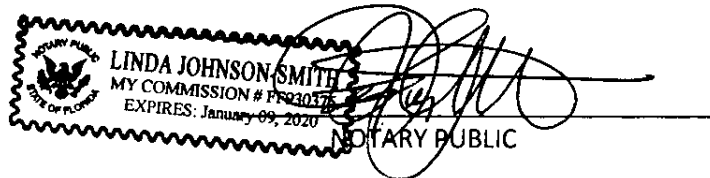
