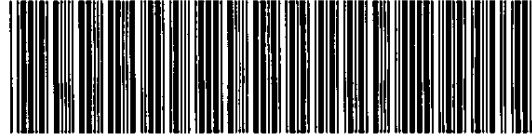

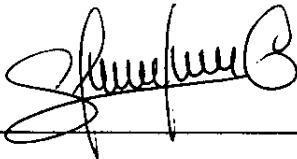

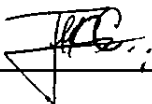
The date of adoption of this amendment was the 15th day of July 2016.
