On May 25, 2016 I attempted to file for a For Profit corporation online at sunbiz.org. However, I picked the wrong application and when I received my articles of incorporation, it was for a Non-Profit corporation. I called in and the agent told me to file for dissolution of the Non-Profit and then wait a few days and file for the For Profit Corporation. I did this and I received a reply saying I could not file for the For-Profit for 120 days or I could provide a notarized affidavit stating that I have no intention of revoking the dissolution of the Non-Profit corporation, therefore releasing the name to be used by another entity.

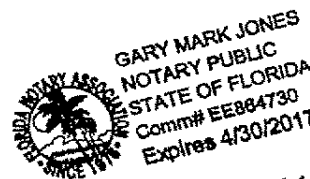
