



ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF GENTS FORMAL WEAR, INC

Pursuant to the provisions of Section 607.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation of GENTS FORMAL WEAR, INC, which were filed on June 14, 2016 and assigned Charter No. P16000051968.
