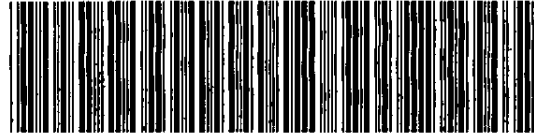



In compliance with the requirements of Florida Statutes Chapter 621 and Chapter 607, the undersigned hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a professional business corporation.

ARTICLE I – Name

The name of this corporation is LEO BRENNINKMEYER PA.

ARTICLE II – Principal Office

The principal office for the transaction of the business of the organization shall be located at Suite B, 120 State Rd 312W, St. Augustine, FL 32086.

The mailing address of the principal office shall be Suite B, 120 State Rd 312W, St. Augustine, FL 32086.

ARTICLE III - Purpose

The purpose for which this professional corporation is organized is to engage in every phase and aspect of the business of rendering the same professional services to the public that a real estate agent or broker, duly licensed under the laws of the State of Florida, is authorized to render, including but not limited to business intermediary services, but such professional services shall be rendered only through officers, employees, and agents who are duly licensed under the laws of the State of Florida to act as a real estate broker or agent.

It is expressly hereby provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this professional corporation otherwise permitted by law.

The number of shares the corporation is authorized to issue is 100 shares of common stock with no par value.
