The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is Tampa Catering Company and its principal office and mailing address is 3501 N. Armenia Ave., Tampa, Florida 33607.

Commencement and Term of Corporate Existence

The corporation shall come into existence on the date of filing with the Florida Secretary of State. This Corporation shall have perpetual existence.

By-Laws


