ARTICLES OF INCORPORATION

OF

WILLIAM V. ROPPOLO, P.A.

The undersigned, being a natural person and duly licensed to practice law under the laws of the State of Florida, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a Professional Service Corporation pursuant to the provisions of the Professional Service Corporation Act (Chapter 621, Florida Statutes), and the Florida General Corporation Act (Chapter 607, Florida Statutes).

FIRST: The name of the professional service corporation (hereinafter called the "corporation") is William V. Roppolo, P.A.

SECOND: The duration of the corporation shall be perpetual.

THIRD: The purposes for which the corporation is organized are as follows:

(a) To engage in every phase and aspect of the practice of law.

(b) To do everything necessary and proper in accomplishing the purposes set forth in this Article and to do anything incidental thereto which is not forbidden under the laws of the State of Florida; provided, however, that only William V. Roppolo, shall be authorized to provide legal services on behalf of the corporation.

<u>FIFTH:</u> The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000), all of which shall have a par value of One Cent (\$0.01) and are of the same class and are to be common shares.

Shares of the corporation's stock shall be issued only to William V. Roppolo.

SEVENTH: No holder of any of the shares of any class of the corporation shall be entitled as of right to subscribe for, purchase, or otherwise acquire any shares of any class of the corporation which the corporation proposes to issue or any rights or options which the corporation proposes to grant for the purchase of shares of any class of the corporation; and any and all of such shares, bonds, securities, or obligations of the corporation, whether now or hereafter authorized or created, may be issued, or may be reissued or transferred if the same have been reacquired and have treasury status, and any and all of such rights and options may be

granted by the Board of Directors to such persons, firms, corporations, and associations, and for such lawful consideration; and on such terms, as the Board of Directors in its discretion may determine, without first offering the same, or any thereof to any said holder.
