ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation under the laws of the State of Florida under Chapter 607 of the Florida Statutes, being the Florida Business Corporation Act, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

No one dealing with the corporation shall be required to inquire as to the identification of the beneficiaries of any trust nor of the provisions or terms of any trust agreement it shall be conclusively presumed that at the time of execution and delivery of any document by the emporation affecting any real property or any interest therein, a trust agreement was in full force and effect, such document was executed in full compliance therewith, and the corporation was duly authorized and empowered to execute and deliver such document.

ARTICLE FIVE: CAPITALIZATION

The corporation shall have the authority to issue 100 shares of common stock with a par value of one penny per share.
