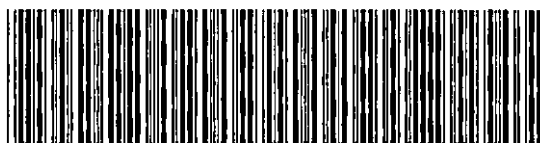

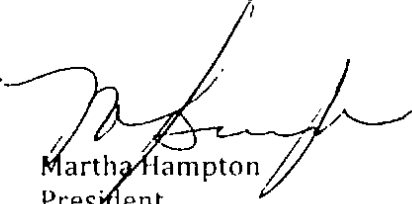

Pursuant to the provisions of section 607.1006, Florida Statutes, the undersigned Florida Profit Corporation ("Corporation") adopts the following articles of amendment to its articles of incorporation.

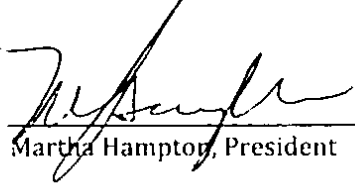
Except as amended above the remainder of the Company's Articles of Incorporation shall remain unchanged and are hereby ratified and confirmed.
