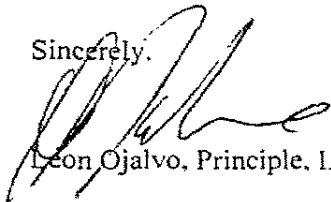
I, Leon Ojalvo, am the principle of both entities.
