**ARTICLES OF INCORPORATION  
OF  
ATLANTIC AEROSERVICE GROUP, INC.**

**ARTICLE I**

The name of the corporation is Atlantic Aeroservice Group, Inc. (hereinafter the "Corporation").

**ARTICLE II**
