

ARTICLES OF INCORPORATION OF ATLANTIC AEROSERVICE GROUP, INC.

ARTICLE I

The name of the corporation is Atlantic Aeroservice Group, Inc. (hereinafter the "Corporation").

ARTICLE II

The address of the principal office and mailing address of the Corporation is 5401 S. Kirkman Rd., Suite 310, Orlando, Florida 32819.

The purpose for which the Corporation is organized is to transact any lawful business.
