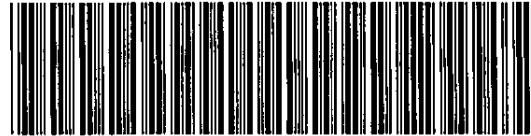


Foolproof, Inc., a Florida corporation, executes the following Articles of Dissolution pursuant to section 607.1401 of the Florida Business Corporation Act:
