SCENE: Internet.

8YNOPSIS: Unknown person used John Elcher's Information to open multiple unauthorized accounts.

INVESTIGATION: On 9/3/16 at 1548 hours, I responded to 4475 Burmuda Drive in reference to an identity Theft.

Upon arrival, contact was made with John Eicher. John advised that on 7/19/16 an unknown person applied for a Barclaycard JetBlue World MasterCard ending in the account has since been closed. Barclaycard would not provide any details as to if the account was used, however, John is not being held liable for any charges that may have taken place.

John also received a letter from Comenity Bank in reference to a Total Rewards Visa Signature credit card ending in the Bank did not advise John of any charges, however, he has received no bills from the bank and is not being held liable for any charges that may have taken place. John stated that on 8/7/18, the unknown subject contacted Comenity Bank via phone and attempted to change the account address. This subject failed to answer a security question, however, and the account was frozen, prompting the mail correspondence that John received.

John also received a coupon from Deluxe Check printing in "late August." John noticed that the coupon contained a business by the name of "Eicher Computer & Electronics" with John Eicher listed as the owner. John was not familiar with this business and contacted Deluxe. Deluxe advised that no checks have been ordered under that business and that any orders placed in that name will have to be authorized by John himself.

John performed an Internet search of this business and discovered a website of intercreditreport.com, where Eicher Computer & Electronics Supply Inc was listed as an active business with a principal address of 3025 Commercial Way. John was listed as a Principal to this business with his current address of 4475 Burmuda Drive listed. According to this website, the business was set up on 7/15/16.

John's search also returned a website of Status Lite.com, where Eicher Computer & Electronics Supply Inc was listed with a telephone of (407) 286-8212 with a website online of eichercomputer.com. I attempted to search eichercomputer.com and was returned with a result previewing the following text: "Eicher Computer & Electronics supply Inc. (407) 286-8212. 3025 Commercial Way. Spring Hill, FL. 34806. US. Phone; 407 286 8212. Get Directions..." at the domain https://eichercomputers-com.3dcartstores.com/crm.asp?action=contactus, however, upon opening the page, the website cannot be displayed.

A Google search of 3025 Commercial Way shows as a valid address located in the Towne Square Mall plaza.

John has already contacted the credit bureaus and placed a freeze on his credit. I advised John to visit the websites victimvoice.org, ftc.gov, and IC3.gov.

John provided a sworn written statement, copies of the letters from both banks, a copy of the Deluxe coupon, a copy of his Equifax confirmation, screen shots of the intercreditreport.com query, as well as the statuslite.com query.
