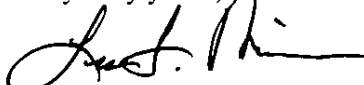

ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose for forming a professional service corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

Article I

Name

The name of the professional service corporation is LEE F. MERCIER, ATTORNEY, P.A.

Article II

Nature of Business

This corporation is specifically organized for the purpose of engaging in the practice of law, operating a law practice, and for the purpose of providing legal services and transacting any or all lawful business related thereto and permitted by law, which shall include serving as trustee, guardian, or other fiduciary, investing the funds of the corporation and owning real or personal property necessary for the rendering of professional services.

Article III

Principal Office

The initial principal place of business and mailing address of the corporation is: 4035 Atlantic Boulevard, Jacksonville, Florida 32207.

Article IV

Capital Stock

A. Number; Par Value. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.

B. Limitation on Issuance and Transfer. The shares may not be issued to any other professional corporation, professional limited liability company or any person not duly qualified and licensed or otherwise legally authorized to provide legal services in the State of Florida.

Article V

Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 4035 Atlantic Boulevard, Jacksonville, Florida 32207, and the name of the initial registered agent of this corporation at that address is Lee F. Mercier, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping the registered office open for service of process.

Article VI

Directors

A. Number. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one.

B. Initial Director. The name and street address of the member of the first board of directors of the corporation is:

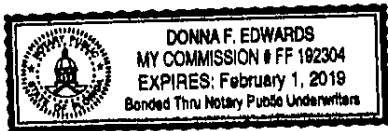
