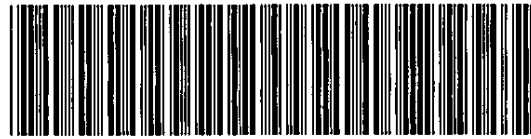

Please be advised that we are not going to reinstate Document P13000101390 which has been administratively dissolved on September 25, 2015.


